

GDPR & PRIVACY STATEMENT

Football 4 All is committed to protecting and respecting the privacy of all children, parents/carers, schools, staff and partners. We process personal information in accordance with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

INFORMATION WE COLLECT

To safely and effectively deliver our coaching sessions, clubs, camps and other activities, we may collect:

- Child's name, date of birth, school and year group
 - Parent/carer names and contact details
 - Emergency contact information
- Medical information, allergies, dietary requirements or additional support needs where relevant
 - Attendance records
 - Booking and payment information
- Accident and incident records where applicable

HOW WE USE INFORMATION

We use personal information to:

- Manage bookings and registrations
- Deliver coaching sessions, clubs, camps and other activities
 - Ensure the safety and wellbeing of participants
- Contact parents/carers regarding bookings, sessions, cancellations or important updates
 - Meet safeguarding and legal obligations
 - Improve and develop our services

CLASSFORKIDS BOOKING PLATFORM

Where activities are booked through ClassForKids, personal information provided during the booking process is collected and stored by ClassForKids on behalf of Football 4 All. ClassForKids acts as a data processor and maintains appropriate privacy and security measures in accordance with applicable data protection legislation.

Football 4 All only accesses and uses the information necessary to administer bookings, communicate with parents/carers, ensure participant welfare and safety, and deliver its coaching programmes and activities. Personal information is handled securely and in accordance with UK GDPR and the Data Protection Act 2018.

SHARING INFORMATION

We will only share personal information where necessary and appropriate, including:

- With schools where required for the delivery of activities
- With emergency services or medical professionals where required for participant safety
- Where required by law or safeguarding obligations

We will never sell, rent or trade personal information to third parties.

DATA SECURITY

Football 4 All takes appropriate technical and organisational measures to protect personal information against unauthorised access, loss, misuse, alteration or disclosure.

RETENTION OF INFORMATION

Personal data will only be retained for as long as necessary to fulfil the purposes for which it was collected, meet legal obligations and comply with safeguarding requirements.

YOUR RIGHTS

Under UK GDPR, individuals have the right to:

- Access their personal data
- Request correction of inaccurate information
- Request deletion of data where appropriate
- Restrict or object to processing in certain circumstances
- Withdraw consent where processing is based on consent
